## **Executive Summaries**

**2019-2020 Fiscal Year summary**: Zero dollars in gross receipts and zero expenses. **Compliance**: The IRS required a filing, so we filed the allowed 990-N postcard. This fiscal year the State of Ohio did not require an annual income report.

**2020-2021 Fiscal Year summary**: ISSEP received supporting contributions in the form of individual donations, memberships, sponsorships, and an "unusual grant" donation, and sold one item of merchandise (a test sale), producing a total revenue of \$101,135. Expenses involved repayment of an advance loan, general management expenses (banking, office, mailing), hiring outside contractors for web development and logo/letterhead design, fundraising, and USPTO filings, as well as program expenses (honorariums, awards), expending a total of \$13,917. As of the close of the 2020-2021 Fiscal Year, ISSEP has \$87,868 cash in the bank. Using the accrual method of accounting (including any accrued pledges incoming or outgoing) ISSEP has \$87,218. <u>Compliance</u>: Following IRS instructions, we have filed Form 990 with Schedules A, B, and O. Following the Ohio Attorney General Office instructions, we similarly filed an annual income report with the State of Ohio.
